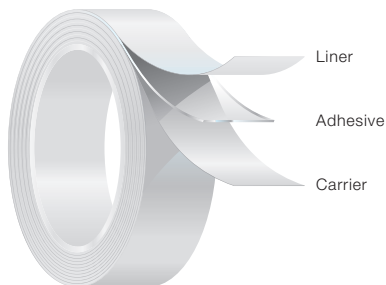

Storage and Shelf Life

Two years when stored at 70°F (21°C), 50% relative humidity, out of direct sunlight, in original packaging.

Safety

The adhesive used on MED 5719P is an acrylic co-polymer. This adhesive has been tested by an independent laboratory on humans as well as animals. The results indicate that the adhesive is non-irritating and non-sensitizing in humans. The tests run on animals were in accordance with Title 16 of the code of Federal Regulations, paragraph 1500.41. The Repeat Insult Patch Test was used to determine sensitization in humans and to indicate potential safe use of MED 5719P in medical devices. 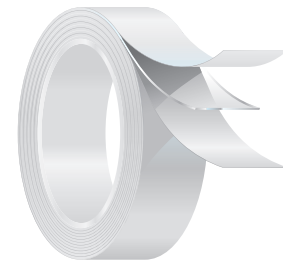
